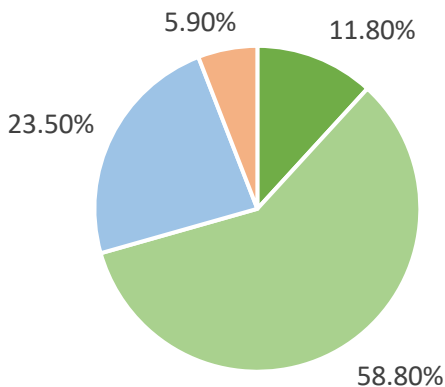

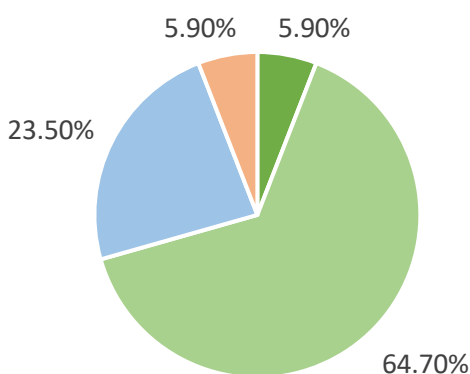
CRITERIA 1 – FEEDBACK ANALYSIS ON CURRICULUM 2021-22 – TEACHERS

1. Feedback Criteria: Syllabus is suitable to the course/programme



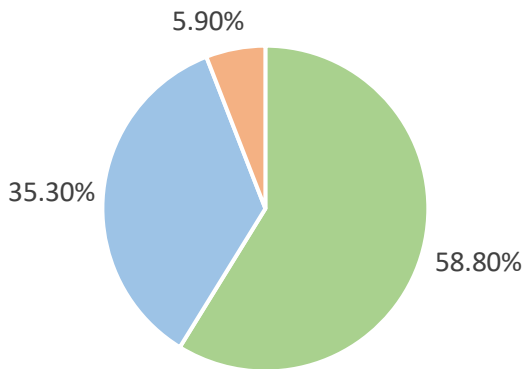

2. Feedback Criteria: The course/syllabus has good balance between theory and practical



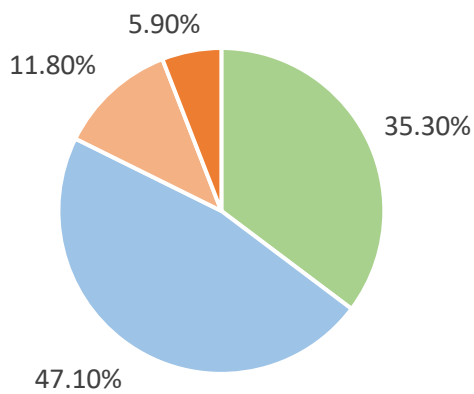

3. Feedback Criteria: Curriculum and syllabus designed to meet the industry standards



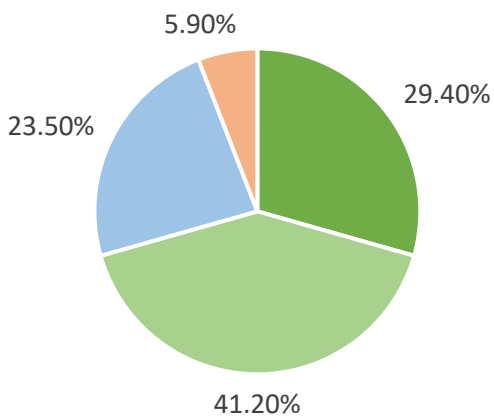

4. Feedback Criteria: Is the syllabus designed in a way to improve employability index



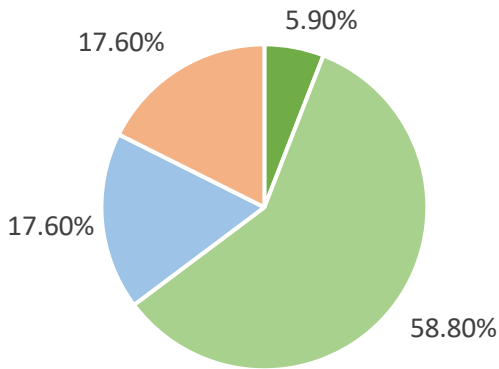

5. Feedback Criteria: Aims and objectives of the syllabi are well defined and clear to teachers and students



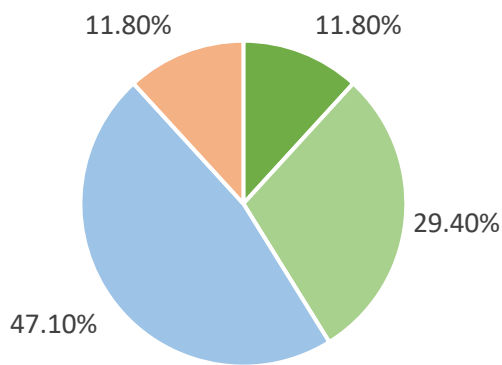

6. Feedback Criteria: Course syllabus is relevant with course learning outcomes, which in turn is aligned to the program outcomes



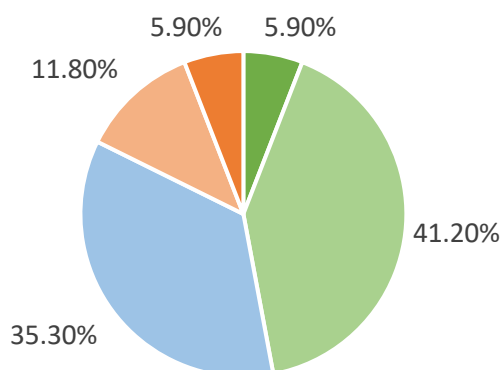

7. Feedback Criteria: The course/syllabus of the subject increased my knowledge and perspective in the subject area



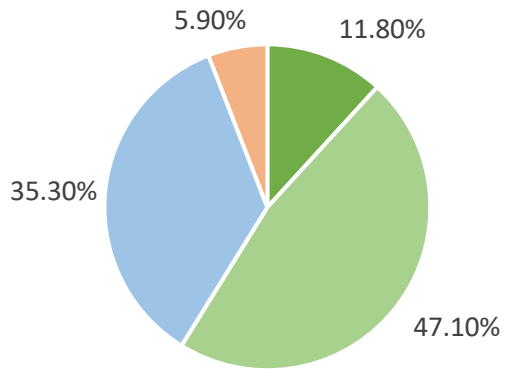

8. Feedback Criteria: Do you think the level of difficulty is appropriate for maximum students?



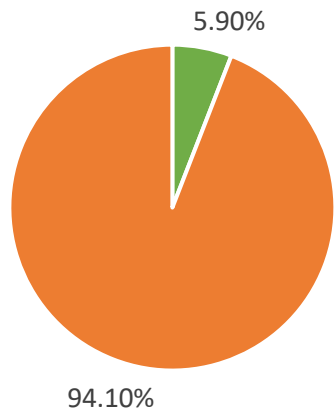

9. Feedback Criteria: The books prescribed/listed as reference materials are relevant, updated, and appropriate



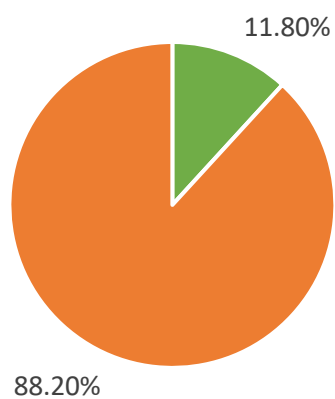

10. Feedback Criteria: Have you contributed to the syllabus revision



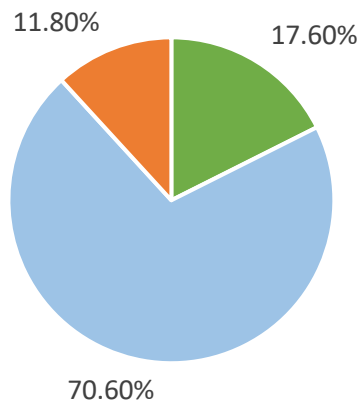
